Data Privacy Statement for Xenia Vision Ltd for the Swapi Swapu Mobile Application (April 2023)

Xenia Vision provides the Swapi Swapu smartphone application, the only app in Mauritius which focuses on a barter system (equal exchange) or swapping (comparable goods/services) to obtain goods or services without the use of currency. It is the first ever marketplace where its members will be able to reduce personal expenses and/or to cut costs of their business. By giving the options of reducing, reusing and recycling, its members are helping to preserve natural resources and energy and hence, protecting the environment in the long-run. Bartering or swapping is simply to exchange something you have for something you want or need and SWAPI SWAPU smartphone application is actually here to help you to recycle your old treasures into something new. You are the one to decide whether it will be done based on equivalent estimates of prices or goods or not...

Xenia Vision processes your data as part of your use of the Swapi Swapu smartphone application in accordance with the pertinent legal regulations.

Section 1

General

The personal data you enter will be collected, processed, and used by Xenia Vision for the purpose of processing the contract in the context of your use of the app. If permitted or required by law, the data may be analyzed for reporting purposes (e.g. statistics).

Your data will be collected, processed and used based solely on the applicable data protection regulations (e.g. with your consent).

We will treat all of your data as strictly confidential, in accordance with statutory provisions.

Section 2

How Swapi Swapu Works

Use of Swapi Swapu app requires installation of and consent to the Terms of Service / Terms of Use and to the Data Privacy Statement for this app.

Section 3

Data Collection, Processing, and Use in Swapi Swapu

Xenia Vision only stores personal data relating to users of its Swapi Swapu if consent for this has been given. Xenia Vision uses this information to measure app activity, to produce app statistics, and to improve the services and information provided via the App.

This App uses Google Analytics. Google Analytics uses a combination of User Agent and IP as a fallback mechanism to identify a session. Google Analytics hashes the resulting identifier, so that no conclusions can be drawn about the original values. This is only based on your consent. You can reject tracking or agree to tracking the first time you open the app. Afterwards you can turn off Google Analytics under "Menu" and "Settings. Insofar only data related to the date and duration of visit and the functionalities of the app are stored. Your IP address will be transmitted anonymously. There is thus at no time the possibility of an unambiguous identification of an app user.

By registering for and using the Swapi Swapu app, the user is granting consent to Xenia Vision to collect, process or use the personal data exclusively - unless otherwise agreed - for satisfying the contractual obligations arising from the user contract for Swapi Swapu, and therefore within the scope of conclusion, performance or termination of this contract. Based on legal requirements, Xenia Vision has enforced global, uniform, and internal data protection rules which regulate the protection of personal data.

The following personal data are processed by Swapi Swapu in the contact form:

First and last name

Email address

Mobile Form

Contact Form – depending on content of the textbox

Xenia Vision saves and uses data entered into the contact form and uses it for the purposes of individual communication with you. The data is stored and used solely for the purpose of answering your questions. Your data is deleted once processing of your request has concluded, provided that this deletion does not conflict with any statutory duties to retain records.
